Crawford Park court failure	B. Jacks	??	B. Jacks saw a city parks maintenance man who recognized me at the CSC on Jan. 9. He had been checking out the Crawford PB courts and could only find one minor area after thoroughly walking all six courts.	This could be a serious and costly issue. Tom Green recommended a surface coating but I am not aware, yes or no, if the recommended coating was used. Regardless, the materials and workmanship typically has a one year warranty. In the case of a PB court, the contractor could make "minor repairs" and then there could be serious surface problems in year 2, 3 etc. From my experience, problems occur in bird bath (ponded water) areas. WAPA should have 2-3 people to monitor and take pictures of the courts after rain. I know for certain that there are bird baths on the courts. Email drafted by EPR and sent to JDG and KH. City has been contacted, city identified Bird Baths, would like Bruce to walk the courts with construction crew.
